January SCC Meeting Minutes January 13 5:30-6:00 pm

- SCC Orientation/ Training Verification
 - All members of SCC have completed the training
 - School Improvement Plan changed to Teachers Student Success Act (TSSA)
- Land Trust Plan
 - o **2020-2021**
 - Most was used on personnel
 - Music teacher and Grade Level Assistants
 - There will be funds left over due to not having the teachers assistants positions filled all year.
 - We will get an updated percentage of what will be left in March
 - Purchased 120 chromebooks
 - The year is based off of a July- June calendar
 - o **2021-2022**
 - The funds should be allocated based on data, but Ridge View was a new school last year and with online school at the end of last year, they were not able to gather the data they would need.
 - Mid-year testing will take place in the next few weeks and we can use the data from that for now.
 - Are we ok to use the funds similarly to how we used them for 2020-2021?
 - What are the growth projections for the new developments? How many more chrome books and ipads will need to be purchased?
 - Electronics need to be rotated out every 5-6 years that we will need to make a plan for in the future.
 - Is it necessary to have a paid grade level assistant or can we have parent volunteers?
 - Due to restrictions volunteers are very limited this year.
 - It is nice to have consistency of one assistant who can come each day and have a schedule/ training on how to help the grade level.
 - We will discuss the 2021-2022 plan more at the next meeting to have it approved.
- Safe Walking Routes
 - Herriman City has adjusted the safe walking routes and will be getting updated maps to the school soon.
 - There will be a few changes to help with future growth.
 - The crossing guards from Lower Meadow and Real Vista will be moved to help with crossing to the new Edge Homes Development
 - There will be a new crosswalk put in on Sentinal Way with hawk lights and crossing guards

- This area needs to be watched because cars speed through here and the fire hydrant has been hit several times.
- There will be a crossing guard at the NE corner of the school
- We will need to watch how traffic flows in and out of new development to ensure the children's safety.
- It may be good to have a police presence when these are starting out to help everyone pay attention and create new routines for the drivers.
- The light at Rosecrest and Sentinal needs to be monitored better. The crossing guards are often distracted and do not help the students cross with the signal and students are left waiting for another light cycle to cross. Due to the light from the sun at this time, it could be dangerous for the children to cross on their own without the crossing guards.
- Some parents have noticed that students are being released early from school and are crossing without a crossing guard present.
 - The school admin will look into this and adjust dismissal times as needed.
- Other
 - Online School: Friday is really short with very little instruction. Is that what is expected on Friday's?
 - Mrs. Doleac will check with the Administrator over online school for the answer.
 - The students who attend school have an easier day on Friday's as well with mostly independent work unless they are invited to come in for small group instruction.
 - We don't know what the schedule for next year will be yet or if it will be the same as this year. That is up to the school board.
 - The land trust link is broken on the school website.
 - The state is updating and will have it up soon.
